


Cross-Border Telehealth Services in EU: a dream or a reality?

The Portuguese Presidency of the Council of the European Union aims to promote greater cooperation between the Member States in the field of health to support the capacity of health services to face threats to public health. To achieve this purpose, telehealth has been established as a Digital Health Priority under the Presidency to increase the quality of healthcare and reduce health access inequalities among EU citizens.

The COVID-19 pandemic undoubtedly challenged the sustainability of healthcare systems and demonstrated the importance of international cooperation to properly tackle cross-border public health challenges. Furthermore, it has emphasised the need to apply digital health solutions to healthcare systems worldwide, such as telehealth tools, to optimize hospital resources while ensuring patients' safety and rights to healthcare access.

However, cross-border telehealth faces several challenges at the national and cross-border level. Therefore, it is important to identify the barriers and enablers to cross-border telehealth, as well as ongoing initiatives, and existing infrastructures to evaluate the possibility of a cross-border telehealth service in the EU.



Objectives

This workshop aims to set the scene for an exchange of views on existing barriers and enablers to cross-border telehealth. In doing so, this workshop will provide a platform to discuss the main hindrances to cross-border telehealth, in an attempt to set in motion a shift towards overcoming existing challenges.

The objective of this workshop (part I of II) is to support a Policy Statement on EU Digital Transformation and the removal of existing barriers to cross-border telehealth, which will be presented to the EPSCO Health and the eHealth Network in June 2021.

Scope and Methodology

This virtual workshop will raise key questions that shall lead the 2nd Cross-Border Telehealth Workshop, in May. By engaging the eHealth community, this collaborative initiative represents the Part I of an interplay process with the relevant parties to discuss the challenges and enablers to telehealth at the cross-border level.

Expected Outcomes

From a comprehensive discussion on the following key topics:

- Cross-border telehealth overview
- Identification of barriers at the cross-border level
- Identification of the enablers to cross-border telehealth
- Build the path to overcome existing challenges (2nd workshop)
